- 1. The Negros Oriental State University (NORSU), through the GAA 2020 intends to apply the sum Six Million Pesos Only (PHP 6,000,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Completion of One-Storey (3)-Classroom Machine and Automotive Shop Phase 2 at NORSU Bayawan Sta. Catalina Campus. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Negros Oriental State University (NORSU) now invites bids for the Completion of One-Storey (3)-Classroom Machine and Automotive Shop Phase 2 at NORSU Bayawan Sta. Catalina Campus. Completion of the Works is required Two Hundred Ten (210) calendar days from the date of receipt of the Notice to Proceed. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instruction to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at

least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

- 4. Interested bidders may obtain further information from Negros Oriental State University (NORSU) BAC Secretariat and inspect the Bidding Documents at the address given below from 9:00 am 5:00 am.
- 5. A complete set of Bidding Documents may be purchased by interested bidders Mondays to Fridays during regular office hours from January 30, 2020 February 11, 2020 at the NORSU-BAC Secretariat upon payment of a non-refundable fee in the amount of Ten Thousand Pesos Only (PHP 10, 000.00) in a form of cash to be paid at the University Cashier, NORSU Main Campus, Dumaguete City.
- 6. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
- 7. The Negros Oriental State University (NORSU) –BAC will hold a Pre-Bid Conference on Thursday, January 30, 2020 @ 1:30 PM at the NORSU BAC Office, 2/F Supply Bldg, NORSU Main Campus, Kagawasan Ave., Dumaguete City which shall be open to prospective bidders.
- 8. Bids must be duly received by the BAC Secretariat at the address below on/or before Tuesday, February 11, 2020 @ 1:00 PM. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
- 9. Bid opening shall be on Tuesday, February 11, 2020 @ 1:30 PM at the NORSU BAC Office, 2/F Supply Bldg, NORSU Main Campus, Kagawasan Ave., Dumaguete City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
- 10. If Bids are submitted by a representative, the said representative should have Special Power of Attorney authorizing him/her to represent the bidder for the said Bidding Activity.
- 11. The Procurement Project is undertaken through EPA (Early Procurement Activities).
- 12. The NEGROS ORIENTAL STATE UNIVERSITY (NORSU) reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders
