

CONSTRUCTION METHODS

1.0 CONSTRUCTION METHODS AND PROCEDURES

CLEARING THE SITE

This item includes removal of all obstructions that obstruct the line area of the road. All surface objects and other protruding obstructions, not designed to remain shall be removed from the natural ground surface and disposed of in a place designated by the Contracting officer.

All such unsuitable materials shall be removed from the building site and spread uniformly over the areas adjacent to the proposed building, or otherwise disposed of as may be directed by the Engineer in charge of the Construction.

EXCAVATION

This Method Statement describes a proper work procedure shall be carried out during the excavation stage as per specification and contract drawings: The area to be excavated shall be properly mark and clear before starting the works. The depth of excavation shall be periodically checked by a surveyor to avoid over excavation.

All excavated material shall be kept minimum of 1.0 meter from the edge of excavation or shall be stock piled to the area designated by the Engineer. For all excavation activities, adequate safety barriers, sign boards, advance warning signs would be used.

Inspection would be conducted during compaction for checking and approval of the Engineer. The compaction test report shall be submitted to the Engineer for approval prior to proceed succeeding work.

REINFORCED CONCRETE STRUCTURE

This method is a versatile composite and one of the most widely used materials in modern construction. Concrete is a relatively brittle material that is strong under compression but less so in tension. Plain, unreinforced concrete is unsuitable for many structures as it is relatively poor at withstanding stresses induced by vibrations, wind loading, and so on.

Concrete mix shall be of class A mixture or a minimum compressive strength of 3,000 psi applied to all concrete structures (Basement Footing, Basement Wall Footing, Basement Tie Beam, Basement Column from footing to construction joint before ground floor, Basement Retaining

Wall from footing to construction joint before ground floor) and in accordance with the standard specifications for reinforced concrete.

Reinforcing steel shall be of grade 60 for 16 mm and up, grade 40 for 12 mm and grade 33 for 10 mm, conforming to Philippine Standard.

Pouring of concrete shall be done with the approval of a pouring permit issued by the Engineer-in-Charge. Placing of concrete shall be made continuous between transverse joints. Necessary hand spreading shall be done with shovels. Workmen shall not be allowed to work in the freshly mixed concrete with boots or shoes coated with earth or foreign substances.

SLAB ON FILL

Concrete slabs may be constructed on filled sites only where the placement of the fill has been strictly controlled. This is referred to as 'controlled fill'. This means the fill material has been carefully selected and compacted in accordance with the procedure set out in AS 2870.

Typically, coarse clean sandy soils are used for this purpose. They are compacted by mechanical rollers. Appropriate amounts of moisture aid the compaction process. The fill is laid down in layers not exceeding 150 mm in thickness. Before the slab is constructed the minimum bearing pressure of the fill must be tested.

Under no circumstances are slabs to be constructed on uncontrolled fill. Uncontrolled fill consists of material that has not been compacted or has been poorly compacted and contains a high portion of expansive clays. This will result in excessive footing movement.

MASONRY

Masonry is a term used to indicate the part of the construction that uses brick, concrete block, structural clay tile, and stone. These materials are held together with mortar. Mortar is a paste form of cement, when it dries it holds together a structure made of bricks, concrete, stone and other materials.

Concrete hollow blocks to be used in this project shall be the 4" CHB. The concrete hollow block walls shall be laid, and the cells filled with cement mortar consisting of 1 part Portland cement and 3 parts sand by volume. They shall be reinforced with deformed bars 10 mm in diameter, spaced at 0.60m on centers for the horizontal bars and at every third layer of CHB shall be installed and tied with G.I. tie wire at all intersections.

All exposed surfaces of concrete hollow block walls shall be finished with the specified materials indicated on the elevation drawings.

The mixture of cement plaster for concrete plaster for concrete hollow block wall finishes indicated in the drawings shall be 1 part cement and 2 parts sand by volume with a minimum thickness of 16mm.

CARPENTRY WORKS

This method includes the installation of doors and accessories and all the ceiling works. A good lumber constitutes a significant component for the quality of the panel doors to be installed. The kind or species of wood pieces required are to be specified in the plans. All panel doors at the basement floor only shall be of solid seasoned dries good lumber. Hardware and accessories shall be pre-approved prior to installation.

Celling works include the installation of fiber cement board and metal furring as frames. All works should be in accordance with plans and specifications.

FINISHES

Painting works shall cover all walls, doors and ceiling at basement only, under slab of ground floor and second floor only. The surface area to be painted is computed from the measurements or scaled distances shown on the project drawing. The calculations should be in square meters and the areas of openings such as windows, fixed glass panels, etc., and those where the coating is of different material, should be deducted from the gross surface area. Paint color shall be pre-approved prior to application.

Tiling works shall comply with all project specifications. Tiles type & color, mortar mix, grout, adhesives, etc., shop drawings and method statements shall be approved by the consultant prior to commencing any tiling works. The areas of the concrete substrate to be tiled are to be brushed clean and dampened and the finished floor level is to be established. The mortar for bedding the tiles shall be as shown in the drawing and/or project specifications.. Engage an experienced installer who has successfully completed tile installations.

PLUMBING WORKS

All plumbing works in the in the project shall be executed according to the provisions of the National Plumbing Code, National Building Code and the Local City Code.

All items whether specifically mentioned or not, or indicated on plans or not shall be finished and installed to complete the system in accordance with the best practice of the plumbing trade and to the satisfaction of the Owner and/or representative.

All plumbing works shall be tested for the effectiveness and workability of water and sewer lines.

ELECTRICAL WORKS

All materials shall be new and shall conform to the Reference Code and Standards. Complete testing and commissioning of all electrical lighting, power and ancillary equipment systems.

All such item whether specially mentioned or not, or indicated in the drawing shall be finished and installed if necessary to complete the work in accordance with the Electrical Cod.

CONSTRUCTION SAFETY AND HEALTH

All works shall comply with safety procedure or instruction as set in out in project Safety Plan and Municipality rules and regulation. Basic Personal Protective Equipment (PPE) shall be worn by all staff or laborers. Trained operator or banks man shall be engaged to control or operate heavy equip.

PROJECT BILLBOARD (8'x8')

This item of work is the installation of project billboard in the site. As part of the contract, the contractor must install an $8' \times 8'$ tarpaulin signboard displayed at the project location. All the details (project name, location, contract amount, duration, start and end date and other details need) of the contract shall be seen in the project billboard. All design and format of the tarpaulin shall be according to the specifications,

ARCTILE III - TIME OF COMPLETION

The work to be performed by the CONTRACTOR under this contract shall commence after seven (7) calendar days upon receipt and acceptance of the Notice to Proceed from NORSU by the CONTRACTOR. The construction of **EXPANSION OF CRIMINOLOGY GUN RANGE BUILDING AT NORSU MAIN CAMPUS 2 (PHASE 2)** shall be completed within **240 calendar days** including Saturdays, Sundays, and holidays. Should the CONTRACTOR refuse or otherwise fail to complete the work stipulated herein, the CONTRACTOR agrees to pay the NEGROS ORIENTAL STATE UNIVERSITY a liquidated damages an amount equal to One-Tenth of One Percent (0.1%) of the total contract sum for each calendar day of delay until the work is completed and accepted by the NORSU or when the NORSU takes over the project by administration or relets it to other contractor until such time as the NORSU may reasonably secure the completion of the works. Such amount shall be deducted from any money due or which may become due the contractor under the contract and/or collect such liquidated damages from performance Bond of the contractor or Contactor's Surety whichever is convenient to the OWNER, NORSU.

ARCTILE IV - THE CONTRACT SUM

The OWNER for and in consideration of the faithful and satisfactory fulfillment of the contract by the CONTRACTOR in accordance with the terms and conditions of all contract documents and subject to the deduction herein provided, shall pay to the CONTRACTOR in Philippine Currency the sum of Nine Million Two Hundred Forty Thousand Pesos Only (Php 9,240,000.00).

Payment shall be in accordance with the following conditions:

a. Progress payments are subject to retention of ten percent (10%) referred to as the "retention money". Such retention shall be based on the total amount due to the Contractor prior to any deduction and shall be retained from every progress payment until fifty percent (50%) of the value of the work as determined by the OWNER are completed. If after fifty percent (50%) completed of the work as determined by the OWNER is satisfactorily done and on schedule no additional retention shall be made on the succeeding progress payment, otherwise, the ten percent (10%) retention shall be imposed. The total retention money shall be due for release upon final acceptance of the works.

The progress payments prior to final billing shall be based on the following:

First Progress Payment = 40% of work completion as determined by the OWNER Second Progress Payment = 60% of work completion
Third Progress Payment = 80% of work completion

Fourth Progress Payment = 90% of work completion

However, after cumulative progress payment to the Contractor amounting to at least fifty percent (40%) of the total contract price, the OWNER may at the written request of the CONTRACTOR release a portion of the retention money commensurate to the percentage of the work completed as determined by the OWNER. Provided, that the CONTRACTOR post an irrevocable standby letter of credit in favor of the OWNER to answer and substitute for the purpose of which the Ten percent (10%) retention is intended. Any release of any amount of the retention money by the OWNER is not to be construed as waiver of the OWNER's right to be indemnified for damage caused by the CONTRACTOR in accordance with the provision of Art.20 of the New Civil Code.

b. The CONTRACTOR shall, under his name and at his own expense, obtain and maintain for the duration of this Contract the following insurance coverage: (1) Contractor's All

Risk Insurance; (2) Transportation to the project Site of Equipment, Machinery, and Supplies owned by the Contractor (3) Personal injury or death of Contractor's employees; and (4) Comprehensive insurance for third party liability to Contractor's direct or indirect act or omission causing damage to third persons.

- c. That the insurance premium shall be the account of the CONTRACTOR.
- d. Progress payment may be revised to conform with the implementation of the Philippine Government's Cash Based Budgeting for FY 2019. To conform with this, a periodic payment may be implemented by the OWNER. Details of the implementation will be agreed upon by the CONTRACTOR and the OWNER within 60 days from the payment of the mobilization/demobilization.

ARTICLE V- PERFORMANCE SECURITY

In accordance with the Instruction to Bidders and General Conditions of the contract, the SUPPLIER shall furnish and file per acceptance to the OWNER a Performance Security in accordance with Section 39 of the Revised Implementing Rules and Regulations of RA 9184 to guaranty the full and faithful performance of this Agreement to answer for any liability that maybe suffered by the OWNER resulting from the violation of the SUPPLIER of labor laws and other laws. PROVIDED, that in the event of the recession or termination of this contract for breach thereof, the Performance Security, at the option of the OWNER shall be automatically forfeited in favor of the OWNER and becomes immediately payable and collectible by the OWNER, otherwise, the Performance Security shall remain and continue in full force until the aforementioned obligations as to the completion and faithful compliance of the contract, liquidated damages and cost of labor and materials shall have been duly satisfied, discharged, settled and paid by the SUPPLIER.

The Performance Security shall be denominated on Philippine Pesos and posted in favor of the OWNER in an amount equal to the following schedule:

2. Warranty Period

- 2.2.1. The CONTRACTOR shall undertake the repair works, at his own expense, of any damage to the infrastructure on account of the use of materials of inferior quality, within ninety (90) days from the time the OWNER has issued an order to undertake repair. In case of failure or refusal to comply with this mandate, the OWNER Entity shall undertake such repair works and shall be entitled to full reimbursement of expenses incurred therein upon demand.
- 2.2.2. The defects liability period shall be covered by the Performance Security of the CONTRACTOR. 2.4 In case of Structural Defects/Failure occurring during the applicable warranty period, the OWNER shall undertake the necessary restoration or reconstruction works and shall be entitled to **full reimbursement** by the CONTRACTOR found to be liable for expenses incurred therein upon demand, without prejudice to the filing of appropriate administrative, civil, and/or criminal charges against the responsible persons as well as the forfeiture of warranty securities posted in favor of the OWNER.

ARCTILE VII - GUARANTEE

The CONTRACTOR hereby guarantee the works stipulated in this contract and all the materials it will apply and use in the construction as well as workmanship of all its work under this contract and shall make good of its own account and/or its own expenses.

After final acceptance of the project by the OWNER, the CONTRACTOR shall assume full responsibility for any damage or destruction of the works except those occasioned by force majeure. They shall be required to put up a warranty security denominated in Philippine Pesos provided in Section 62.2.3.3 of IRRA of R. A. 9184 and shall remain effective for one (1) year

from date of issuance of the certificate of final acceptance and shall be retuned only after the lapse of the said one (1) year period.

In addition, the provisions of An. 1723 of the New Civil Code shall also apply to guarantee the work performance of the CONTRACTOR.

ARCTILE VIII - USE OF CONTRACT DOCUMENTS AND INFORMATION

The Supplier shall not, except for purposes of performing the obligations in this Contract, without the Procuring Entity's prior written consent, disclose this Contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the Procuring Entity. Any such disclosure shall be made in confidence and shall extend only as far as may be necessary for purposes of such performance.

Any document, other than this Contract itself, shall remain the property of the OWNER and shall be returned (all copies) to the OWNER on completion of the Supplier's performance under this Contract if so required by the Procuring Entity.

ARCTILE IX-SAFEGUARDS AND WARRANTS

The CONTRACTOR shall provide and do everything necessary to perform its obligations under this contract according to the true intent and meaning of the other contract documents taken together particularly the drawings, plans and specifications provided that the same shall be inferred there form and should the CONTRACTOR find any discrepancy in the drawings, plans and specifications, he shall immediately refer the same to the OWNER University Engineer/Inspection Team and/or the OWNER whose decision shall be followed.

The OWNER reserves the right for an additional or increase in the number of laborers or workers assigned to the construction site in the opinion of the OWNER the exigencies of the same require.

The CONTRACTOR shall be considered as an independent CONTRACTOR and as such, he assumes all obligations and liabilities arising out of the Employee's Liability Act and any other laws existing and those enacted thereafter that may affect the rights of the employees or laborers employed in the performance of this contract. Should the OWNER be made liable for any of the Contractor's violation of any labor laws, the CONTRACTOR shall reimburse OWNER for whatever amount the latter is required to pay to said laborers and the Performance Bond is also answerable for this contingency.

Notwithstanding any provisions of this contract the OWNER has the right and/or power to terminate the contract without necessity of judicial action by giving written notice to the CONTRACTOR upon his failure to comply strictly with any of the terms of this contract.

The contract hereby warrants that it has not given or promised to give money or gift to any official or employee of the OWNER and/or any other office, agency or instrumentality of the government to secure this contract and any violation of this warranty shall be sufficient ground for the OWNER to revoke or cancel the same.

The CONTRACTOR is likewise mandated to implement the construction safety and health program as indicated in the Technical Requirements of the Bid Documents submitted by the CONTRACTOR which includes, among others, requiring its employees to have Identification Cards which should be available anytime when inspected by security personnel of the university or any authorized representative of the OWNER.

ARCTILE X - LIABILITY OF THE OWNER

From the Start Date until the Certificate of Final Acceptance has been issued, the following are risks of the OWNER:

- 1. The risk of personal injury, death, or loss of or damage to property (excluding the Works, Plant, Materials, and Equipment), which are due to:
 - Any type of use or occupation of the Site authorized by the OWNER after the official acceptance of the works; or
 - Negligence, breach of statutory duty, or interference with any legal right by the OWNER or by any person employed by or contracted to him except the Contractor.
- 2. The risk of damage to the Works, Plant, Materials, and Equipment to the extent that it is due to a fault of the OWNER or in the Procuring Entity's design, or due to war or radioactive contamination directly affecting the country where the Works are to be executed.

ARCTILE XI – LIABILITY OF THE CONTRACTOR

The CONTRACTOR shall, under his name and at his own expense, obtain and maintain, for the duration of this Contract, the following insurance coverage:

- 1. CONTRACTOR's All Risk Insurance;
- 2. Transportation to the project Site of Equipment, Machinery, and Supplies owned by the CONTRACTOR;
- 3. Personal injury or death of CONTRACTOR's employees; and
- 4. Comprehensive insurance for third party liability to CONTRACTOR's direct or indirect act or omission causing damage to third persons.

The CONTRACTOR shall provide evidence to the OWNER that the insurances required under this Contract have been effected and shall, within a reasonable time, provide copies of the insurance policies to the OWNER.

The CONTRACTOR shall notify the insurers of changes in the nature, extent, or program for the execution of the Works and ensure the adequacy of the insurances at all times in accordance with the terms of this Contract and shall produce to the OWNER the insurance policies in force including the receipts for payment of the current premiums. The insurance policies shall be obtained from any reputable insurance company approved by the OWNER.

If the CONTRACTOR fails to obtain and keep in force the insurances referred to herein or any other insurance which he may be required to obtain under the terms of this Contract, the OWNER may obtain and keep in force any such insurances and pay such premiums as may be necessary for the purpose. From time to time, the OWNER may deduct the amount it shall pay for said premiums including twenty five percent (25%) therein from any monies due, or which may become due, to the CONTRACTOR, without prejudice to the OWNER exercising its right to impose other sanctions against the CONTRACTOR pursuant to the provisions of this Contract.

In the event the CONTRACTOR fails to observe the above safeguards, the OWNER may, at the CONTRACTOR's expense, take whatever measure is deemed necessary for its protection and that of the CONTRACTOR's personnel and third parties, and/or order the interruption of dangerous Works. In addition, the OWNER may refuse to make the payments until the Contractor complies with this Clause.

The CONTRACTOR shall immediately replace the insurance policy obtained as required in this Contract, without need of the OWNER's demand, with a new policy issued by a new insurance company acceptable to the OWNER if the issuer of the insurance policy to be replaced has:

1. become bankrupt;

2. been placed under receivership or under a management committee;

ARCTILE XII - TERMINATION OF CONTRACT

1. Termination for Default of Contractor

The OWNER shall terminate this Contract for default when any of the following conditions attend its implementation:

- 1.1 Due to the Contractor's fault and while the project is on-going, it has incurred negative slippage of fifteen percent (15%) or more in accordance with Presidential Decree 1870, regardless of whether or not previous warnings and notices have been issued for the Contractor to improve his performance;
- 1.2 Due to its own fault and after this Contract time has expired, the Contractor incurs delay in the completion of the Work after this Contract has expired; or

1.3 The Contractor:

- abandons the contract Works, refuses or fails to comply with a valid instruction of the OWNER or fails to proceed expeditiously and without delay despite a written notice by the Procuring Entity;
- does not actually have on the project Site the minimum essential equipment listed on the bid necessary to prosecute the Works in accordance with the approved Program of Work and equipment deployment schedule as required for the project;
- does not execute the Works in accordance with this Contract or persistently or flagrantly neglects to carry out its obligations under this Contract;
- neglects or refuses to remove materials or to perform a new Work that has been rejected as defective or unsuitable; or
- sub-lets any part of this Contract without approval by the Procuring Entity.

All materials on the Site, Plant, Works, including Equipment purchased and funded under the Contract shall be deemed to be the property of the OWNER if this Contract is rescinded because of the Contractor's default.

2 Termination for Default of Procuring Entity

The Contractor may terminate this Contract with the OWNER if the works are completely stopped for a continuous period of at least sixty (60) calendar days through no fault of its own, due to any of the following reasons:

- Failure of the OWNER to deliver, within a reasonable time, supplies, materials, right-ofway, or other items it is obligated to furnish under the terms of this Contract; or
- The prosecution of the Work is disrupted by the adverse peace and order situation, as certified by the Armed Forces of the Philippines Provincial Commander and approved by the Secretary of National Defense.

3. Termination for Other Causes

The OWNER may terminate this Contract, in whole or in part, at any time for its convenience. The OWNER may terminate this Contract for the convenience of the OWNER if he has determined the existence of conditions that make Project Implementation economically, financially or technically impractical and/or unnecessary, such as, but not limited to, fortuitous event(s) or changes in law and National Government policies.

The OWNER or the Contractor may terminate this Contract if the other party causes a fundamental breach of this Contract.

4. Breaches of Contract

In this event, termination will be without compensation to the CONTRACTOR, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the OWNER and/or the In the case of the CONTRACTOR 's insolvency, any CONTRACTOR. CONTRACTOR's Equipment which the OWNER instructs in the notice is to be used until the completion of the Works;
- (d) A payment certified by the OWNER is not paid by the OWNER to the CONTRACTOR within eighty four (84) days from the date of the OWNER 's certificate;
- (e) The OWNER gives Notice that failure to correct a particular Defect is a fundamental breach of Contract and the CONTRACTOR fails to correct it within a reasonable period of time determined by the OWNER;
- (f) The CONTRACTOR does not maintain a Security, which is required;
- (g) The CONTRACTOR has delayed the completion of the Works by the number of days for which the maximum amount of liquidated damages can be paid; and
- (h) In case it is determined prima facie by the OWNER that the CONTRACTOR has engaged, before or during the implementation of the contract, in unlawful deeds and behaviors relative to contract acquisition and implementation, such as, but not limited to, the following:
 - corrupt, fraudulent, collusive, coercive, and obstructive practices;
 - drawing up or using forged documents;
 - using adulterated materials, means or methods, or engaging in production contrary to rules of science or the trade; and
 - any other act analogous to the foregoing.

The OWNER, as appropriate, will seek to impose the maximum civil, administrative and/or criminal penalties available under the applicable law on individuals and organizations deemed to be involved with corrupt, fraudulent, or coercive practices.

When persons from either party to this Contract gives notice of a fundamental breach to the OWNER in order to terminate the existing contract for a cause, the OWNER shall decide whether the breach is fundamental or not.

If this Contract is terminated, the Contractor shall stop work immediately, make the Site safe and secure, and leave the Site as soon as reasonably possible.

4. Procedures for Termination of Contracts

The following provisions shall govern the procedures for the termination of this Contract:

- (a) Upon receipt of a written report of acts or causes which may constitute ground(s) for termination as aforementioned, or upon its own initiative, the OWNER shall, within a period of seven (7) calendar days, verify the existence of such ground(s) and cause the execution of a Verified Report, with all relevant evidence attached;
- (b) Upon recommendation by the Procuring Entity, the OWNER shall terminate this Contract only by a written notice to the Contractor conveying the termination of this Contract. The notice shall state:
 - that this Contract is being terminated for any of the ground(s) afore-mentioned, and a statement of the acts that constitute the ground(s) constituting the same;
 - the extent of termination, whether in whole or in part;
 - an instruction to the Contractor to show cause as to why this Contract should not be terminated; and
 - special instructions of the Procuring Entity, if any.

The Notice to Terminate shall be accompanied by a copy of the Verified Report;

- (a) Within a period of seven (7) calendar days from receipt of the Notice of Termination, the Contractor shall submit to the OWNER a verified position paper stating why the contract should not be terminated. If the Contractor fails to show cause after the lapse of the seven (7) day period, either by inaction or by default, the OWNER shall issue an order terminating the contract;
- (b) The OWNER may, at anytime before receipt of the Contractor's verified position paper described in item (c) above withdraw the Notice to Terminate if it is determined that certain items or works subject of the notice had been completed, delivered, or performed before the Contractor's receipt of the notice;
- (c) Within a non-extendable period of ten (10) calendar days from receipt of the verified position paper, the OWNER shall decide whether or not to terminate this Contract. It shall serve a written notice to the Contractor of its decision and, unless otherwise provided in the said notice, this Contract is deemed terminated from receipt of the Contractor of the notice of decision. The termination shall only be based on the ground(s) stated in the Notice to Terminate; and

Pursuant to Section 69(f) of RA 9184 and without prejudice to the imposition of additional administrative sanctions as the internal rules of the agency may provide and/or further criminal prosecution as provided by applicable laws, the OWNER shall impose on contractors after the termination of the contract the penalty of suspension for one (1) year for the first offense, suspension for two (2) years for the second offense from participating in the public bidding process, for violations committed during the contract implementation stage, which include but not limited to the following:

- 1. Failure of the contractor, due solely to his fault or negligence, to mobilize and start work or performance within the specified period in the Notice to Proceed ("NTP");
- 2. Failure by the contractor to fully and faithfully comply with its contractual obligations without valid cause, or failure by the contractor to comply with any written lawful instruction of the OWNER or its representative(s) pursuant to the implementation of the contract. Employment of competent technical personnel, competent engineers and/or work supervisors;

- Provision of warning signs and barricades in accordance with approved plans and specifications and contract provisions;
- Stockpiling in proper places of all materials and removal from the project site of
 waste and excess materials, including broken pavement and excavated debris in
 accordance with approved plans and specifications and contract provisions;
- Deployment of committed equipment, facilities, support staff and manpower; and
- Renewal of the effectivity dates of the performance security after its expiration during the course of contract implementation.
- Assignment and subcontracting of the contract or any part thereof or substitution of key personnel named in the proposal without prior written approval by the procuring entity.
- 4. Poor performance by the contractor or unsatisfactory quality and/or progress of work arising from his fault or negligence as reflected in the Constructor's Performance Evaluation System ("CPES") rating sheet. In the absence of the CPES rating sheet, the existing performance monitoring system of the OWNER shall be applied. Any of the following acts by the Contractor shall be construed as poor performance:
 - Negative slippage of 15% and above within the critical path of the project due entirely to the fault or negligence of the contractor; and
 - Quality of materials and workmanship not complying with the approved specifications arising from the contractor's fault or negligence.5. Willful or deliberate abandonment or non-performance of the project or contract by the contractor resulting to substantial breach thereof without lawful and/or just cause.
- 5. In addition to the penalty of suspension, the performance security posted by the contractor shall also be forfeited.

5. Force Majeure, Release from Performance

For purposes of this Contract the terms "force majeure" and "fortuitous event" may be used interchangeably. In this regard, a fortuitous event or force majeure shall be interpreted to mean an event which the Contractor could not have foreseen, or which though foreseen, was inevitable. It shall not include ordinary unfavorable weather conditions; and any other cause the







effects of which could have been avoided with the exercise of reasonable diligence by the Contractor.

If this Contract is discontinued by an outbreak of war or by any other event entirely outside the control of either the OWNER or the Contractor, the OWNER shall certify that this Contract has been discontinued. The Contractor shall make the Site safe and stop work as quickly as possible after receiving this certificate and shall be paid for all works carried out before receiving it and for any Work carried out afterwards to which a commitment was made.

If the event continues for a period of eighty four (84) days, either party may then give notice of termination, which shall take effect twenty eight (28) days after the giving of the notice.

After termination, the Contractor shall be entitled to payment of the unpaid balance of the value of the Works executed and of the materials and Plant reasonably delivered to the Site, adjusted by the following:

- (a) any sum to which the Contractor is entitled
- (b) the cost of his suspension and demobilization;
- (c) any sum to which the OWNER is entitled.

The net balance due shall be paid or repaid within a reasonable time period from the time of the notice of termination.

ARCTILE XIII - VENUE OF COURT ACTION

Should any court action be instituted by the NORSU or CONTRACTOR arising from this contract, the parties hereby agree that the venue thereof shall be the proper court in the province of Negros Oriental.
