# MEMORANDUM OF AGREEMENT (Orientation Training on the Getaprofessor application)

### KNOW EVERYONE BY THESE PRESENTS:

This Memorandum of Agreement, the "Agreement", is entered into by and between:

BETTY McCANN, and hereinafter referred to as "SU"; GetaProfessor, an incubatee of SU TBI, herein represented by its founder REUBEN J C. LOS BAÑOS and hereinafter referred to as "GETAPROFESSOR"

NEGROS ORIENTAL STATE UNIVERSITY (NOrSU), a State University in Negros Oriental created under Republic Act 9299 on June 25, 2004 with office address at Kagawasan Avenue, Dumaguete City, Negros Oriental, duly represented by its President, HON. JOEL P. LIMSON, Ph. D., duly authorized per BOR Res. No. \_\_\_\_\_, series \_\_\_\_ and hereinafter represented as "NOrSU"

#### WITNESSETH

WHEREAS, GETAPROFESSOR, is tasked to train faculty at NORSU in a period of 3(three) months from December 2021 to March 2022.

WHEREAS, SU, thru its TBI, and NOrSU have agreed to become partners to closely elaborate and assist each other in providing support to the participants of the Orientation Training on the Getaprofessor application.

NOW, THEREFORE, for and in consideration of the foregoing premises and of the terms and conditions herein set forth, the parties do hereby mutually agree, within the limits of the laws governing their existence, on the following:







## 1. Responsibilities of SU TBI

- a. Assist Getaprofessor on the conduct of the "Orientation Training on the Getaprofessor application".
- Assist Getaprofessor on the creation of Certificate of Recognition/ Appreciation and Certificates of Appearance to participants.
- c. Ensures that Getaprofessor complies with its duties and responsibilities (Section 1.1) as a trainer to NOrSU.
- d. Award Certificates of Completion/ Recognition to all qualified training participants and award Certificate of Appreciation to facilitators, resource persons and to those who have significant contributions for the success of the project.
- e. Assist Getaprofessor in using the data collected to improve its application.

## 1.1 Responsibilities of Getaprofessor

- a. Prepare the presentation materials and train participants on the use of the Getaprofessor app.
- b. Provide full support to the participants for the implementation & sustainability of the use of the social learning application.
- c. Give all possible content knowledge, its application and course standards across the teachers' training on the use of the Getaprofessor application.

## 2. Responsibilities of NORSU

- a. Provide key participants from among its regular faculty members and staff representing various colleges/ departments across all campuses in the province for the "Orientation Training on the Getaprofessor application".
- b. Assist SU TBI and Getaprofessor in the conduct of the "Orientation Training on the Getaprofessor application".
- c. Ensure the implementation of the Getaprofessor app by its faculty and students after the training.
- d. Provide feedback from the participants on the use of the Getaprofessor application for the improvement of the Getaprofessor software and possible use of feedback data for research purposes.
- e. Award Certificates of Appreciation to facilitators, resource persons and to those who have significant contributions for the success of the project.





## 3. Separability Clause

If any part or provisions of this Agreement is declared invalid, the other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

### 4. Amendments

At anytime while this MOA is in effect, any provision hereof maybe amended, revised, supplemented with the written consent of the parties;

## 5. Effectivity and Duration

The MOA shall take effect upon its signing by the parties and shall terminate automatically upon completion of the obligations stated herein by the parties.
