

MEMORANDUM OF UNDERSTANDING (MOU)

KNOW ALL MEN BY THESE PRESENTS:

This document serves to record an understanding between:

Dr. Daniel Helman from the **COLLEGE OF MICRONESIA-FEDERATED STATES OF MICRONESIA (COM-FSM)** hereafter known as the **Resource Person from COM-FSM)**
and

NEGROS ORIENTAL STATE UNIVERSITY (hereafter known as **NORSU**).

Preamble

The purpose of this Memorandum of Understanding (MOU) is to clarify the expectations, roles, and responsibilities of the collaboration between the aforementioned Parties

Intent to Collaborate

It is the intent of the aforementioned Parties to jointly collaborate on the implementation of the following:

- Lectures and/or Research about Ideas for Active Learning in a Student-Centered Classroom
- Lectures and/or Research about New Activities to Engage Student Learning
- Lectures and/or Research about Using Language-Learning Techniques for Teaching Math and Science
- Lectures and/or Research about Constructivism and Authority: Some New Ideas for Teaching and Learning

Timeline:

The aforementioned activities will take effect from March 20, 2023, until this MOU is terminated/revoked.

Roles and Responsibilities

The aforementioned parties will communicate as needed about the implementation and progress of the aforementioned activities.

Coordination and Communication

All communications about the aforementioned activities will take place between the **Resource Person from COM-FSM** and the **Contact Persons of NORSU**

MODIFICATION AND TERMINATION

A. This MOU may be amended and/or extended by mutual agreement of the aforementioned Parties. Any such amendment or extension shall be made by written mutual consent of the aforementioned Parties with the same formality as this original MOU.

B. This MOU may be terminated in whole or in part by either Party, upon ninety (90) days written notice, if such Party determines that termination is in its best interest.

C. If either Party has failed to comply with the terms of this MOU, either Party may, upon ninety (90) days prior written notice to the other Party, terminate this MOU. The notice of termination shall state the reason(s) for the termination and the effective date.


